Terms and Conditions

1. **Membership:** Family and Corporate memberships include hunting, fishing, hiking, biking, picnicking, use land for dog training and discounts to sporting clays. Weekday membership is for hunting only. Membership is good for one year from the month joined and automatically renews each year.
2. **Payments for Birds and Services:** Charges for Additional Birds and Services will be paid for on the day that such charges are incurred. Members have the option of putting their charges on their member account or pay as they go. Such charges will be billed to the Member's credit card provided in conjunction with this Membership Application or other means deemed acceptable by The Hunt Club of Richmond, LLC prior to the Member incurring any charges.
3. **Monthly Statements:** Monthly charges, are payable as of the monthly statement date. At the first day of the month following the statement, the account becomes past due and is subject to interest at a rate of one and half percent (1.5%) per month from the date of the initial billing. If a statement is not paid in full for two (2) months, The Hunt Club of Richmond, LLC may suspend membership privileges and initiate collection proceedings.
4. **Membership Termination:** Membership may be terminated upon thirty (30) days' written notice to The Hunt Club of Richmond, LLC but membership dues will not be refunded. Membership may not be terminated unless the Member's account is paid in full. The Hunt Club of Richmond, LLC reserves the right to terminate the member's membership at any time for any reason.

5. Miscellaneous: Any litigation arising from being a member of The Hunt Club of Richmond, LLC shall be governed by the laws of the state of Illinois and any claims shall be filed in the courts of McHenry County, Illinois. Member agrees to reimburse The Hunt Club of Richmond, LLC for any costs, including reasonable attorneys' fees, associated with the collection of past due monthly dues and/or other charges.
